To the stallion Cornelis BP24 if the stallion is alive, fit to breed and standing at Stonebrook, under the following terms and conditions.

Terms and Conditions

1. The Mare Owner shall pay a non refundable booking fee of \$ 250. The booking fee is due payable to Cornelis BP24 upon execution of this contract.

The Mare Owner shall pay a non refundable stud fee of \$ 1000.00 due payable to Cornelis BP24 before semen is shipped and the mare is bred. Breeding fee is only for the above mentioned mare.

This is a contract for shipped semen. All charges related to collection, shipping and container deposits must be paid in full prior to shipment of semen. The cost for the collection and shipment of semen is \$350.00 (all fees are in USD)

Semen will be collected on weekdays only. Stallion Owners/Agents must be notified by phone by 12 noon EST the day prior to collection. We cannot guarantee that late orders can be accommodated and there will be additional fees up to \$75.00 for late orders.

Please note the semen is NOT collected on site. Mare owners must check the website for availability.

In the event a second collection/shipment of semen is required the cost will be \$350.00 payable to the Stallion Owners/Agents prior to collection/shipment of the semen. Any further collection/shipments will be \$350.00 per collection/shipment payable to Stallion Owners/Agents prior to collection/shipment of the semen.

2. The Mare Owner shall return a copy of the mare's papers and a photo with this contract or the photo can be emailed to cornelisbp24@gmail.com. This contract is subject to acceptance of the mare/mares by the Stallion Owners/Agents. If the mare/mares is not acceptable to the Stallion owners/agents, at its sole option, Stallion Owners/Agents shall return the booking fee to the mare owner and this contract shall be void.
3. Mare Owner agrees to fill out and return the **BREEDING REPORTS-breeding soundness, insemination and pregnancy or loss of pregnancy report** according to the instructions therein. **IF THESE REPORTS ARE NOT RECEIVED AS INSTRUCTED, ALL GUARANTEES, REFUNDS, BREEDINGS OR REGISTRATION POSSIBILITIES ARE NULL AND VOID** The cooled semen container must be returned promptly and those not received within 7 days will be charged \$30.00/day rental.
4. Live Foal Guarantee: This contract is a "live foal" contract. A "live foal" is defined as a newborn foal which stands and nurses without assistance. Should this mating not produce a live foal, it must be evidenced by a licensed veterinarian and the loss of pregnancy report signed by the said veterinarian within one week from the date of death of the fetus/foal or in the alternative, a sworn statement (in writing) from said veterinarian that the mare is no longer in foal and the date of fetus loss is unknown, within one month of the mare's expected foaling date. If the foal is born dead, or if the mare does not carry to term or if the mare fails to become pregnant, there shall be return privilege for the following breeding season (2018). At the close of the 2018 breeding season, this breeding contract becomes null and void and no refunds will be given to the Mare Owner and no rebreeding will be offered. In the event of the death or sale of the stallion, this contract will become null and void and the stud fee less the non refundable booking fee shall be refunded to the mare owner if the mare has not been bred. In the event of the stallion's death, inability to be collected or sale of the stallion prior to delivery of a live foal, the live foal guarantee shall become null and void. Should the mare be deemed unsuitable for breeding by a licensed veterinarian or die prior to breeding, the mare owner will be allowed to substitute a new mare at the stallion owners/agents discretion. No refunds shall be permitted. No other fees are

refundable except as described in this paragraph. No fees related to collection, shipping or settling the mare are refundable. Collection and shipping fees may change from year to year. Mare Owner agrees to pay the booking, collection and shipping fees which are current for the year mare is bred. Collection and shipping fees are only guaranteed for the 2017 breeding season.

5. Mare Owner agrees to take proper care of the pregnant mare, including proper feeding and nutrition, regular dewormings with products approved for pregnant mares, vaccinations customary in the mare's geographical area, and proper intervention during foaling if necessary. The mare must be vaccinated against Rhinopneumonitis on the 5th, 7th and 9th month as verified by a licensed veterinarian, or the live foal guarantee shall not apply and the Mare Owner will not be entitled to any rebreeding, refunds or credits of any kind.
6. Mare Owner certifies that the attending veterinarian is experienced in or familiar with artificial insemination and practices equine reproduction as a regular part of the practice. Please see our breeding page for Mare care management to fresh semen
7. A Breeders Certificate will be issued when the Mare Owner notifies Stallion Owners/Agents of the birth of the foal and only after the **BREEDING REPORT** has been received and the breeding soundness, insemination and pregnancy forms have signed by a licensed veterinarian and returned to the Stallion owners/agents. A picture of the foal standing next to the mare must be emailed to cornelisbp24@gmail.com.
8. Mare owner agrees to hold Stallion Owners/Agents harmless if the mare does not settle.
9. This agreement constitutes the entire agreement between the parties; any amendment to or modifications of the terms of this agreement must be in writing. Failure of Mare Owner to adhere to the terms of this contract will make this contract (including the Live Foal Guarantee) null and void and no fees, or monies will be refunded to the Mare Owner.
